Builders Trust Announces Rate Decrease



Due to your continuing efforts in maintaining safe workplaces and job sites, the frequency and severity of claims continues to drop. Therefore, the Builders Trust Board of Trustees is pleased to announce that they approved a 7.5%

overall rate decrease for 2022 which has been approved by the Workers' Compensation Administration. Rates went down for 104 class codes, 56 had no change and only nine codes had slight increases. Fifty class codes have over a 10% decrease, with ten having more than a 20% decrease. We have applied for approval from the Work-

ers' Compensation Administration for our 2022 rates to be effective with your January 2022 payroll reporting.

The Builders Trust Board continues to work to keep Participants competitive in the marketplace. In addition, there has been no decrease in the number of services offered to our Participants and in fact, we continue to add to our already robust assortment of services.

Have you taken a look at your Participant Manual? If not, you are missing out on a lot of *great* information. The manual is updated periodically and can be easily accessed on our website by logging into your BT PAL account and selecting the tab entitled *Resources* on the left and then select **Participant Manual**.

The procedures and guidelines are designed to help you with risk management and represent a key component of your ownership in the Builders Trust Self-Insurance Fund.

One nice feature of the online manual is that it is in Adobe Reader format, which allows you to search the document once downloaded. The search function provides a quick way to look up a particular subject in the manual. The manual contains a substantial amount of information in both Spanish and English. You will find useful forms such as a sample job application, a safety meeting sign-off sheet, a return-towork agreement and so much more. The *Builders Trust Participant Manual* is, literally, chock full of valuable information and forms to make your job easier.

As you begin to dig into the manual, we highly recommend you not skip the early pages, as there is historical information about Builders Trust of New Mexico. This includes our **Mission statement** and **Core Values**. Take some time to read these, as

our Mission Statement and Core Values drive everything we do for you and your injured workers.

As you continue through the manual you will see the list of our Board of Trustees who reside in many different areas of New Mexico and a list of staff. The manual is over 80 pages and near the back you will find detailed information and dozens of forms covering many key areas of interest.

As a reminder, **BT-PAL** (Participant & Agent Link) is your internet access to a wide variety of Builders Trust information and services. For example, once you log on to BT PAL you can complete your monthly Payroll Reporting Forms, make a premium payment, and access reports to view your loss history and claims data.

WCA 2021 Annual Report Released

The Workers' Compensation Administration (WCA) just released their 2021 Annual Report. Although full of interesting information the below stood out.

It was reported that lost time claims (indemnity claims) in the construction industry are .72 claims per 100 workers and represents 11.4% of all claims in New Mexico. For Builders Trust Participants, that number is slightly higher at just over one employee per 100. Therefore, if you have 20 workers, you should have only one lost time claim every five years. Ten workers mean one lost time claim every ten years.

We would encourage you to take a look at your lost time injuries and if you are having more that the average, take a look at why and then take the initiative to fix it. Builders Trust can help and has many training videos at your disposal as well as in person training (like our mobile training center above.)
